### **MEETING MINUTES:**

#### Welcome

DFO Kreps and Chairman Swinko briefly welcomed the Committee and provided an overview of the meeting agenda and expectations regarding the discussion with Commerce senior officials.

### **Presentation of ETTAC Recommendations**

Michael Corvese presented the Committee's recommendations on trade promotion, including trade lead generation, dissemination, tracking and metrics. Debra Waggoner presented the Committee's recommendations related to trade policy and competitiveness, including on trade negotiations (NAFTA and the WTO Environmental Goods Agreement (EGA)), ITA's Market Development Cooperator Program (MDCP) and export financing. Peter Tunnicliffe gave a presentation on the Committee's recommendations regarding Brazil. ADUS Kemp received the recommendations on behalf of Secretary Ross, and then she and Assistant Secretary Nikakhtar and Deputy Assistant Secretary Steff engaged in discussion and Q&A with the Committee.

### ETTAC Subcommittee Breakout Meetings with ETWG Representatives

Subcommittees met with interagency representatives of the Trade Promotion Coordinating Committee's Environmental Trade Working Group (ETWG) to discuss the ETTAC's recommendations and the formulation of U.S. Government responses. The Professional Services and Infrastructure Advancement (PSIA) Subcommittee also discussed development of a new potential recommendation related to tied aid. DFO Kreps and Chair Swinko wrapped up with a discussion of next steps, including plans for a joint ETTAC-ETWG meeting on July 24 during which ETWG officials would formally address the Committee's recommendations.

## **Discussion of Committee Administration and Re-Chartering**

DFO Kreps reviewed the re-chartering process and next steps regarding the nomination process for the 2018-2020 charter.
