- NAFTA
 - Do no harm
 - Fully recognize and use international standards
 - IP Chapter should reflect current standards
 - Bring environmental side letters into the agreement





Environmental Goods Agreement

- Global market of \$1 trillion in 2015
- U.S. exports \$51 billion
- Tariffs still major impediment
 - As high as 35% in key markets
- Need to make this a priority
 - 2016 negotiations suspended, but very close
 - Administration could deliver major deal relatively quickly



Market Development Cooperator Program

- Leverages private sector -- \$2 for every MDCP award \$1
- Supports annually
 - 3,200 jobs
 - \$32 million in exports
- \$2 million US program investment
 - Excellent ROI -- \$336 in exports for every \$1 awarded



Export Financing

- BRICS combined total of \$51B 2016 -- nearly ½ of all official export credit provided globally
- For example, restrictions on coal-fired powered plants funding cedes ground to competitors in China, Japan, Korea
 - Projects \$1B and US ExIm limited \$10M per project without quorum
 - U.S. suppliers of pollution control technology lose out to foreign competitors

- Overcapacity -- 232 Steel and Aluminum
- IP theft -- 301 IP Report on China
 - Right issues to address
- 232 tariffs
 - Appreciate the product and country exemption processes
 - Increased cost and supply disruptions
 - Carbon and stainless steel increases of 7-40%
- China IP 301
 - Appreciate the ability to comment
 - Encourage Administration to work with EU, Japan, Korea and other allies facing shared challenge
- ETTAC stands ready to work on solutions that enhance industry's ability to compete in a fair global market
